Youth gets 50-year jail for sexually abusing minor girl

T'Puram: The Fast Track Special Court in Thiruvananthapuram has sentenced Suith, 25, from Thiruvallam to 50 years of rigorous imprisonment and imposed a fine of Rs 35,000 on him for sexually assaulting a 15-year-old girl after entering her house and staying there for several days. The judgment was delivered by Judge Anju Meera Birla. The court ordered that the fine amount be given to the survivor. If the convict fails to pay the fine, he will have to serve an additional one-anda-half-years in prison. The incident happened on September 6, 2021. The accused entered the girl's room and sexually assaulted her, asking her to remain silent. He continued to stay inside the house for eight days and repeatedly raped her.
