Chandigarh: 3 doctors booked for 'medical negligence' that led to woman's death

THE CHANDIGARH Police has registered a case against three doctors for alleged medical negligence that led to the death of a 49-year-old woman during her treatment in the city.

The FIR, lodged at the Sector 39 police station on the directions of a local court, names Dr Kuldeep Singh, owner of Santokh Hospital, Dr Gurnaj Singh, and Dr Ravinder Goyal. No

arrests have been made so far. According to the complaint filed by Madan Pal, a resident of

Sector 47-D, his wife Mamta was suffering from severe abdominal pain and was taken on November 25, 2020, at Santokh Hospital, After medical tests, she was diagnosed with gallbladder stones. While the complainant had initially requested treatment through medication, Singh allegedly insisted that surgery was the only viable option.

Mamta was admitted to Santokh Hospital and operated on November 27, 2020. However, her condition reportedly worsened after the surgery. She developed acute stomach pain, difficulty in breathing, swelling, and leakage from the drainage pipe site. On November 30. Singh informed the family about a blockage near the liver and advised stenting/ERCP. Goyal was called for consultation and the ERCP was carried out at Shalby Hospital, Mohali, on December 1, after which Mamta was brought back to Santokh Hospital the same afternoon.

Despite repeated requests for urgent care, Madan Pal alleged, the doctors failed to take necessary remedial measures. He alleged that he later discovered that Singh, who performed the surgery, was not professionally qualified to conduct it, and that during the procedure, a nerve was accidentally cut, leading to discharge and complications.

As Mamta's condition continued to deteriorate, the family shifted her to the PGIMER, Chandigarh, on December 6, 2020. The next day, she was declared dead. The death certificate from the PGIMER cited the cause of death as "septic shock with MODS" — a life-threatening condition caused by a severe infection, leading to multiple organ failure and dangerously low blood pressure.

In his written complaint dated January 18, 2021, to the Senior Superintendent of Police,

Chandigarh, Madan Pal accused the three doctors of gross negligence, mishandling, and ignoring repeated pleas to save his wife's life. He alleged that the doctors were more focused on extracting large sums of money from patients than on providing

Acting on the complaint, and order of the court, the police have registered a case under sections 304-A (causing death by negligence) and 34 (acts done by several persons in furtherance of common intention) of the Indian Penal Code. Police have initiated an investigation into the matter.

YouTuber booked for spreading false information about Haryana CET

THE PANCHKULA police has registered an FIR against a YouTuber for allegedly spreading misleading and false information about the Haryana Common Eligibility Test (CET) on social media.

Inspector Rupesh Chaudhary, SHO of Sector-5 police station, said that on August 1, HSSC official Kedar Singh filed a complaint alleging that Prince Lamba, a journalist-anchor of the YouTube channel Haryana News 24, had uploaded two videos on July 26 and 27 regarding the CET exami-

nation. The videos carried sensational headlines such as 'CET Cancelled, Will the Paper be Held Again' and 'HSSC's Big Betrayal of Lakhs of Youth! Uproar in

Haryana". According to the complaint, these videos created confusion among lakhs of candidates in the

state. Deputy Commissioner of Police (DCP) Srishti Gupta said that, considering the seriousness of the matter, a case has been registered against the accused under sections 335 and 353(1)(b) of the Bharatiya Nyaya Sanhita (BNS), and an investigation is underway.

Man assaulted, robbed of ₹7,000; one arrested, two on the run

Mohali: In a case of assault and robbery in Kandala village in Mohali, police have registered an FIR against the three accused.

Mandeep Singh, a resident of Bakarpur village, in his complaint stated that on the night of August 7, before leaving for his duty, he went to Kandala village to get a shave. As the shop was closed, he bought a cold drink and was returning when Sandeep and Neeraj, and their associate allegedly surrounded him due to a personal grudge. "The accused attacked me with a kirpan, an iron rod, and fists," the complainant added. They allegedly took Rs 7,000 from his pocket.
